LATE FEES

I agree that all equipment is due on the date specified at the time I book my trip and must be either returned to Matt's Marketing Ventures LLC dba Backcountry Packraft Rentals in person by the agreed upon return date, or postmarked for return shipping on the prearranged return shipping day. The prearranged return shipping day is the day after the end of the rental period. If equipment is returned late, a late fee will be charged. The late fee will be two times the rate of the last day of the rental for each piece of equipment (raft, paddle etc.) for each day not returned. ACCEPTING EQUIPMENT

I agree to inspect all equipment rented from Matt's Marketing Ventures LLC dba Backcountry Packraft Rentals. If upon inspection of the equipment shipped, I find any damage or missing parts before I have used the equipment, I agree to notify Matt's Marketing Ventures dba Backcountry Packraft Rentals immediately of the damage or missing parts. I understand that if I fail to notify Matt's Marketing Ventures dba Backcountry Packraft Rentals of damage or missing parts before I use the equipment , I will be held responsible for any damage that occurs during the time the raft is rented in my name. REPAIR AND REPLACEMENT FEES

I accept full responsibility for the care of all rented equipment. If any equipment is lost, stolen and/or damaged the charge will be equivalent to the replacement value of the entire item or the repair cost if the item is repairable. If a part is broken or lost and can be replaced, the cost of the part will be assigned as a repair fee. Renters will be contacted with the total fee amount prior to their card being charged. CLEANING FEES

Why do we ask for your credit card number here? We process your rental credit card through paypal, which means we don't actually have your credit card number online.

The credit card you list here will only be charged for the following: shipping, late fees, cleaning fees and damage or loss fees. Because shipping varies greatly depending on what you rent and where you live, we have to calculate that after you book. Estimated shipping is \$30-40 for a single raft and \$10-15 after that for each additional raft. Paddles and PFDs increase shipping costs significantly. Late fees, cleaning fees, loss fees and damage fees will only be charged to this card in applicable situations. By giving us your credit card on this form, you are authorizing us to charge this credit card for the purposes listed above.
